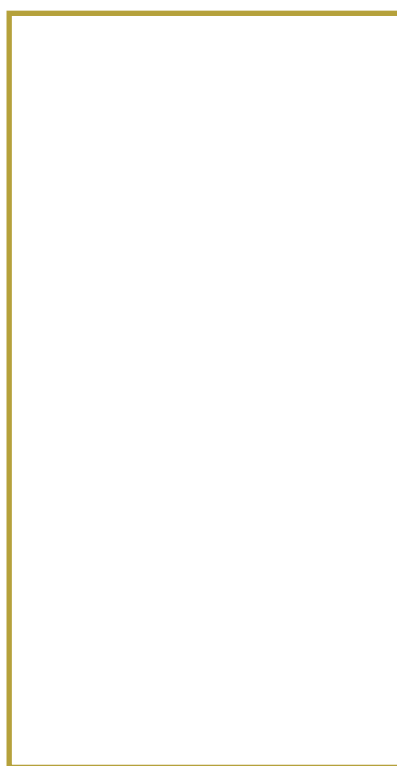

# Customs Law and Supply Chain Management

The international movement of goods requires extensive **advance planning of supply chains** in order to evaluate and, where possible, reduce the impact of **sanctions, tax and environmental regulations** on their flow, as well as **to expedite trade**, while still guaranteeing an accurate calculation of border taxes and ensuring compliance with **safety and ethical requirements** imposed by the European Union and national legislation.

The professionals in our Customs Law & Supply Chain Management practice take a multidisciplinary and strategic approach to providing ongoing, **project-based support** to both companies and customs agents.

This is aimed at:

- **optimising internal procedures** for customs management, including determining the preferential **origin and classification of goods**, and additional customs requirements, such as those arising from the carbon border adjustment mechanism (**CBAM**), the EU forced labour regulations and the deforestation regulation (**EUDR**)
- **Streamlining trade flows**, including support with customs approved **locations and special regimes**, and with obtaining certifications like **AEO, REX** and **Authorised Exporter**
- **Submitting appeals to the customs authorities** in order to obtain binding decisions, as well as providing **legal assistance** in the course of **disputes** with the public authorities following investigations into import and export operations

# Golden Power

## Control of foreign direct investments

The professionals at Studio Legale Padovan have gained considerable experience in the Italian Golden Power regulations, relating to the special powers that can be exercised by the government in certain sectors in order to safeguard the assets of companies operating in areas considered strategic and of national interest. The relevant sectors include defense and national security, energy, transport, 5G, communications, advanced technologies such as artificial intelligence, robotics, semiconductors, cybersecurity, nanotechnology, biotechnology, access to and control of sensitive data and information, dual-use products, health, the financial and credit sector, non-military aerospace technologies, and various others. The firm also provides assistance in European Union and individual jurisdictions regulations on foreign direct investment control, also thanks to the AT+ICA network of specialized law firms, which it helped to found.

### **Activities:**

- Assistance in the interpretation and application of Golden Power regulations, with particular regard to verifying the existence of the conditions for application in terms of identifying both the relevant sector or assets and the type of transaction.
- Strategic support in structuring corporate transactions in compliance with Golden Power regulations.
- Assistance in drafting and filing notifications and pre-notifications required by Golden Power regulations and in the related administrative proceedings before the Presidency of the Council of Ministers.
- Assistance in drafting and reviewing deeds, contracts, and corporate resolutions in light of Golden Power regulations.
- Support for continuous monitoring and internal compliance (including integrated compliance) of companies operating in strategic sectors with respect to Golden Power regulations and the applicability of such regulations to corporate transactions, deeds, contracts, or resolutions, including the preparation and review of internal compliance procedures and models and their possible integration with existing company procedures and models, and assistance in the interpretation and application of any requirements imposed by the Presidency of the Council of Ministers.
